**For Brightness:** The consignment will be accepted with proportionate deduction on basic price upto 90% ISO and below 90% consignment will be rejected.

**03.QUALITY:**

**04. VALIDITY:**

**05. TRANSPORTATION:**

- b) The material should be despatched in trucks by road on freight PAID basis. Freight charges shall be claimed by way of separate Debit Note. If separate work order to be issued for transportation, the same should be indicated in the Serial no.4 (b) of the Technical cum Commercial Bid along with name and address of the transporter and a consent letter from them.
- c) It is the sole responsibility of the supplier to settle the applicable Service Tax to the statutory Authorities in case of their claiming freight charges through Invoice / Debit note.

**06. TERMS OF PAYMENT:**

- Our normal terms of payment is within 30 days from the date of receipt of material subject to acceptance by **Pugalur cheque**. However, it may please be noted that offers asking payment in advance or through bank are liable for rejection.

**07. DUTIES AND TAXES:**

Duties, Educational Cess on ED, Secondary Higher Education Cess and taxes etc if applicable should be mentioned clearly and separately with the percentage of duties and taxes applicable.

**CENVAT:**

Duplicate copy of Excise duty invoice should be sent along with each supply for the purpose of availing CENVAT credit. Copy of ED invoice should be sent in a separate cover addressed to A.G.M. **08. SAMPLE:**

**All the Tenderers suppliers should submit Minimum 2 Kg sample of DRY GROUND CALCIUM CARBONATE** as per the specification mentioned in clause no.2 along with Technical Cum Commercial Bid without fail. In case of non receipt of sample along with the tender, the tender will not be considered. Those who fail to submit the sample in time and whose sample is not found acceptable, their tender will not be considered. The tenderers are expected to submit only one sample meeting our requirement. In case any tenderer submits more than one sample, only one sample will be tested and the result of such sample will be considered for evaluation purpose. In case sample is sent separately, please ensure that the same should reach us on or before **29-07-2010**. TNPL will not be responsible for any delay in receipt of sample and sample received after **29-07-2010** will not be accepted. Tenders containing inadequate sample will not be considered.

**09. PACKING AND MARKING:**

Material shall be accepted subject to meeting the following packing standards.

- (a) Material shall be supplied in compact 50 Kgs bags only.
- (b) Leak proof single layer HDPE or PAPER bags shall be used to pack the material.
- (c) PAPER BAGS are preferred. Provision for handling the bags without usage of hooks shall be made by stitching grippers at all the four corners.
- (d) Name of the supplier, Product name, Weight, Date of manufacture should be mentioned on the bag.
- (e) Hooks shall not be used for loading at vendor's works.
- (f) The 50 Kg bags shall strictly be sized within the following dimensions.  
Length: 600 to 1000 mm; Width : 450 to 800 mm; BULKNESS: 100 – 250 MM

**Instead of 50 Kgs Packing, if TNPL prefers to have Precipitated Calcium Carbonate in Jumbo bags of 1MT. Vendors may indicate whether they are in position to supply 1 MT jumbo bag with the same marking as mentioned above,**

**10. DELIVERY:**

In the event of an order, you shall be in a position to start supplies within short notice and despatches are to be effected as per delivery schedule given by TNPL from time to time.

**11. DELAY OR NON DELIVERY:**

Time is the essence of the contract and completion of delivery dates agreed to are binding on the seller. In the event the seller is not able to supply as per the delivery schedules given by TNPL, Purchaser will have a right either to cancel the order without prejudice to any other rights or to make purchase from an alternate source at the risk and cost of the seller.

**12. REJECTION:**

**TNPL requires DRY GROUND CALCIUM CARBONATE strictly as per our specification given in S.No.2 above. Material not meeting our specification will be rejected outright and the rejected material shall be taken back within 7 days and replacement should be made within 7 days from the date of intimation.**

13. In case of rejection and failure to replace goods, the order will be treated as incomplete and we may cancel the order and will arrange to purchase the goods from elsewhere at your risk and cost and the purchase order on you will be cancelled and action taken as per the order terms .

**14. EARNEST MONEY DEPOSIT:**
